Article 1

OBJECTIVE OF COOPERATION

The objective of this Memorandum of Understanding (MOU) is to cooperate in educational projects in areas of mutual interest

Article 2

SCOPE OF COOPERATION

The Parties agree to implement cooperation programmes including but not limited to:

- b. Faculty and student exchanges.
- c. Skills based certification/add on certification courses.

- e. Access of students of both institutions to quality enhancement programmes organized at both the institutions.

Article 3

Article 4

LOCATION OF ACTIVITIES

1. The Parties agree to implement the programmes stated in Article 2 at Vidyanagar College and K.K.Das College.
2. Any changes of the location of the programmes shall be mutually agreed upon by the Parties.

Article 5

MODE OF CONDUCTING THE PROGRAMMES


The programmes will be conducted primarily in the Offline mode. Ample arrangements should also be made to conduct programmes in the online mode.

AMENDMENT


- 1) This MOU may be amended or revised at any time by mutual written consent of the Parties and such amendment shall form an integral part of this MOU,


