2.5.) Promoting other academic cooperation as mutually agreed.


3.) Both the Institutions agree that prior approval is required before using the other institution's name and logo in any kind of publicizing activity.


4.) This MoU may only be amended or modified by a written agreement signed by both the Head of Institutions.

5.) This MoU is valid for a period of five years from the date of signing by the authorized signatories of each College. Each College shall review the status of the MoU in the very beginning of every academic year before the end of the five-year period to determine whether it wishes the MoU to continue and if so, any modifications that might be necessary. The period of validity of this MoU may only be extended by the mutual written consent of both the Institutions.

6.) This MoU may, at any time during its period of validity, be terminated by one of the colleges upon prior notice to the other in writing not later than six months before the termination date.
