Article 1

OBJECTIVE OF COOPERATION

The objective of this Memorandum of Understanding (MOU) is to cooperate in educational projects in areas of mutual interest.

Article 2

SCOPE OF COOPERATION

The Parties agree to implement cooperation programmes including but not limited to:

- Exchange on best practices.
- Faculty and student exchanges.
- Skill based certification/add on certification courses.
- Organizing seminars/webinars/conferences/symposia.
- Access of students of both institutions to quality enhancement programmes organized at the same.

Article 3

FINANCIAL ARRANGEMENT

Any cooperation under this MOU is subject to the availability of funding sources and approval by relevant authorities.

Article 4

LOCATION OF ACTIVITIES

The Parties agree to implement the programmes stated in Article 2 at Vidyanagar College and Women's Christian College. Any changes of the location of the programmes shall be mutually agreed upon by the Parties.

Article 5


MODE OF CONDUCTING THE PROGRAMMES


The programmes will be conducted primarily in the Offline mode. However, ample arrangements should also be made to conduct programmes in the online mode, should the necessity occur.

Article 6

DURATION AND TERMINATION

- This MOU shall enter into force on the date of signing.
- The MOU shall remain in force for a period of five(5) years and may be extended for another period of five(5) years by the mutual written consent of the Parties.
