### Article 1

#### OBJECTIVE OF COOPERATION

The objective of this Memorandum of Understanding (MoU) is to co-operate each other in educational projects in areas of mutual interest

### Article 2

#### SCOPE OF COOPERATION

The Parties agree to implement co-operative programmes including but not limited to:

- a. Exchange of best practices.
- b. Faculty and student exchanges.
- c. Skill based certification / add on certification courses.
- d. Organizing seminars / webinars / conferences / symposia, etc.
- e. Access of students of both institutions to quality enhancement programmes organized at both the institutions.
- f. Undertaking Joint Research Programmes where possible.

### Article 3

#### FINANCIAL ARRANGEMENT

Any cooperation under this MOU is subject to the availability of funding sources and approval of the relevant authorities.

### Article 4

#### LOCATION OF ACTIVITIES

1. The Parties agree to implement the programmes stated in Article 2 at Harimohan Ghose College and Kultali B.R.Ambedkar College.
2. Any changes of the location of the programmes shall be mutually agreed upon by the Parties.

### Article 5

#### MODE OF CONDUCTING THE PROGRAMMES

The programmes will be conducted primarily in the Offline mode. Ample arrangements should also be made to conduct programmes in the Online mode if required.

### Article 6

#### DURATION AND TERMINATION

#### Article 7


#### AMENDMENT
