
ACTION TAKEN REPORT ON TEACHERS' FEEDBACK

The Teachers' Feedback was discussed in the meeting of the IQAC held on 09.01.2023. The Coordinator of the IQAC, Dr. Arunima Ray Chowdhury had made the following observations: While most of the Teachers are favorably disposed to our College, there are certain areas where there is scope for improvement such as i) cleanliness of the campus ii) ICT support to teachers iii) library access iv) democratization in the administrative functioning.

ACTION TAKEN REPORT ON THE STUDENTS' FEEDBACK


The Students' Feedback was discussed in the meeting of the IQAC held on 19.05.2023. The Coordinator of IQAC, Dr. Arunima Ray Chowdhury had taken note of that students' feedback and concluded that while most of the students have rated our college with positive responses nonetheless, she emphasized on the following aspects which required closer scrutiny:

- Cleanliness of the washrooms meant for the students
- Study materials provided to the students
- Completion of the syllabus on time
- Conduct of examinations
- Cooperation by the office staff towards the students

On the basis of the above observations, under the instructions of Dr. Surja Prakash Agarwala, Principal, the following actions have been taken:

- ❖ The Establishment Sub Committee ensured regular cleaning of the washrooms meant for the students
- ❖ The Academic Sub Committee requested each department to look into the matter of making study materials available for every student so that no one gets left out
- ❖ The Academic Sub Committee has urged every department to take extra classes if at any time portions of the syllabus is not covered in time
- ❖ The Examination Sub Committee has assured the Principal that although the exam routines are determined by the University of Calcutta, the notices of internal evaluation will be put up both on the notice board as well as on the college website and the departmental Whatapp groups to make the students informed on time.

Rate the process of democratization in the administrative functioning of the College

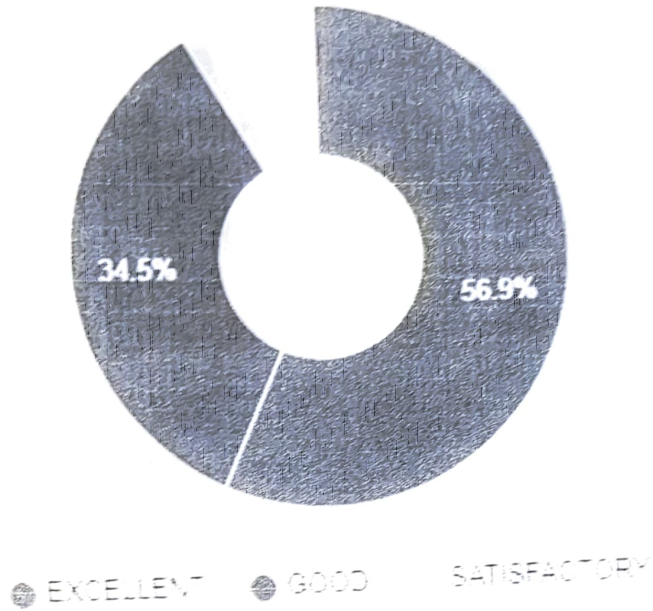

Analysis Chart

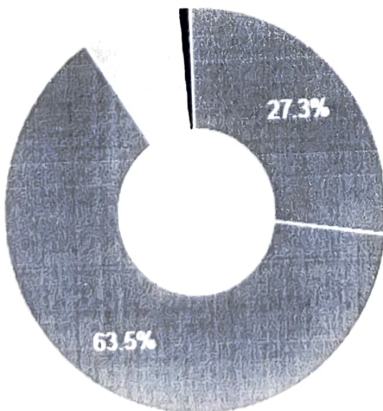

ACTION TAKEN REPORT ON THE ALUMNI MEMBERS' FEEDBACK

The IQAC had taken note of the Alumni members' feedback and concluded that while most of our former students have rated our college with positive responses nonetheless, the body emphasized on the following aspects which required closer scrutiny:

- The laboratories must be improved. They must be ICT compliant. More instruments especially for the Physics and Chemistry laboratories must be procured
- The College needs more teachers and for that necessary communications with the Government of West Bengal must be initiated
- While there is not much can be done with the examination procedure since it has to be conducted as per University of Calcutta's rules, the college can improve the tables and benches for the students.

On the basis of the above observations the following actions have been taken:

- The Physics and the Chemistry laboratories are undergoing a total overhauling. A new dark room has been set up. New racks for chemicals and desks with wash basins, gas lines, waste disposal lines for the Chemistry laboratory is being set up.
- The Governing Body has already resolved that the process of post creation has to be initiated immediately.
- New sets of tables and benches have already been procured.


ACTION TAKEN REPORT ON THE EMPLOYERS' FEEDBACK

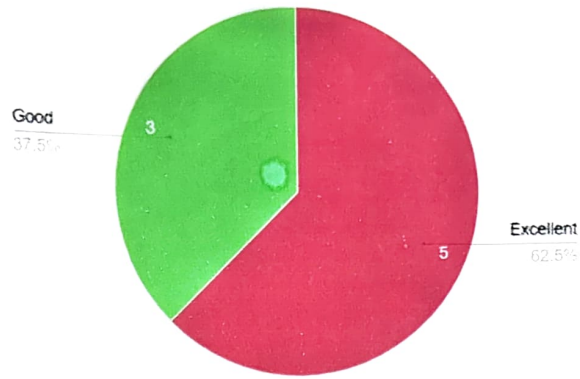
- ◆ The level of skill acquired by our students during their stay in our college is still not up to the mark.

On the basis of the above observations the following actions have been taken:

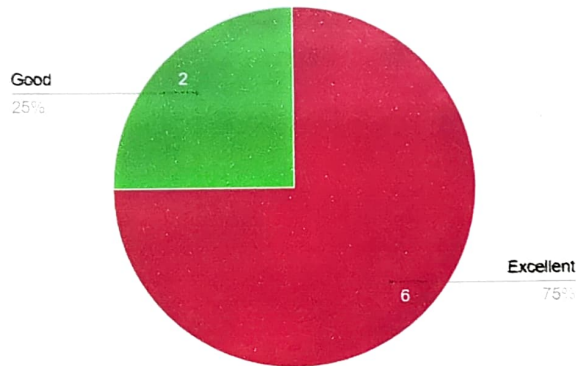
- The College has already introduced Value Added Courses.

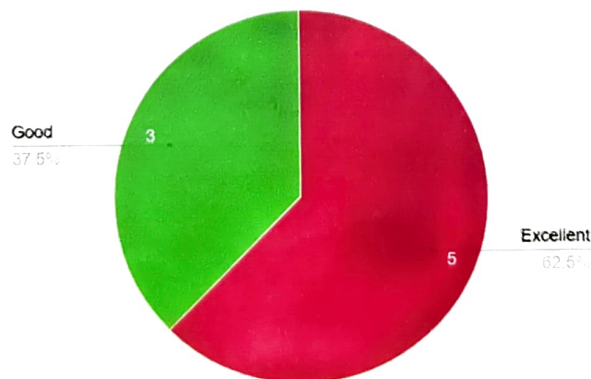
Rate the course that you have learnt in the College in relation to your present profession

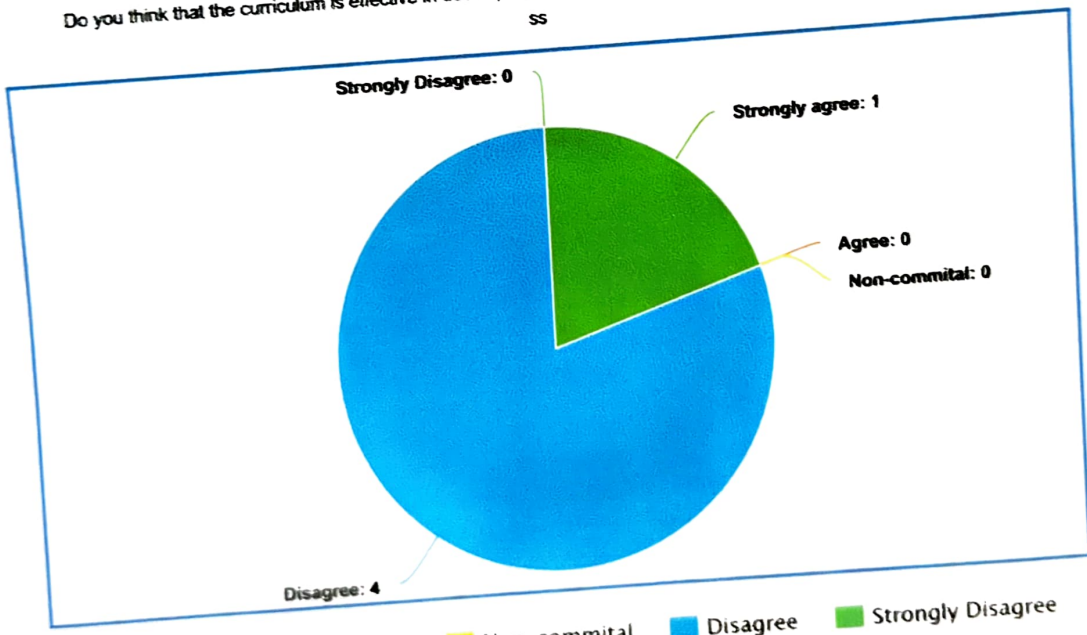


Do you think that the curriculum is conducive to the development of entrepreneurship skills in the employee?

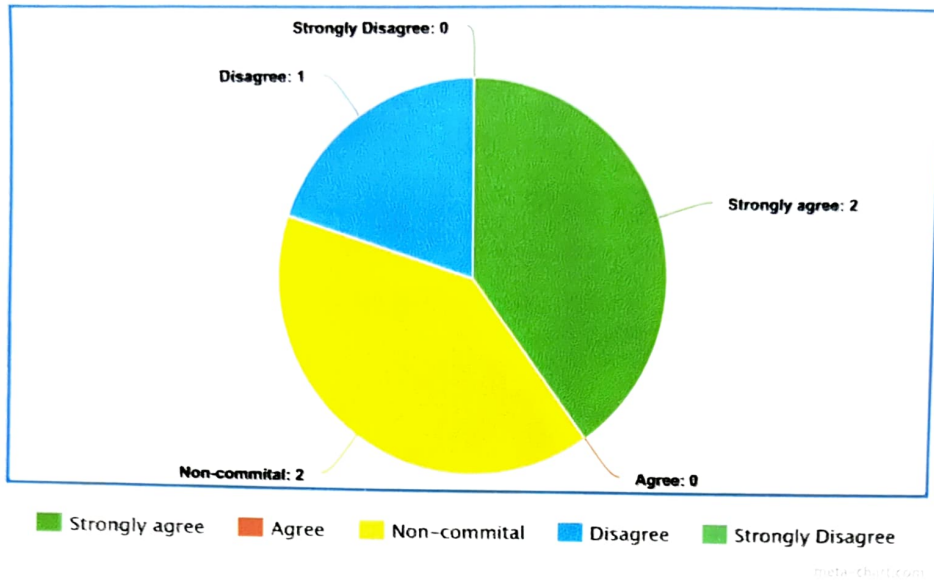

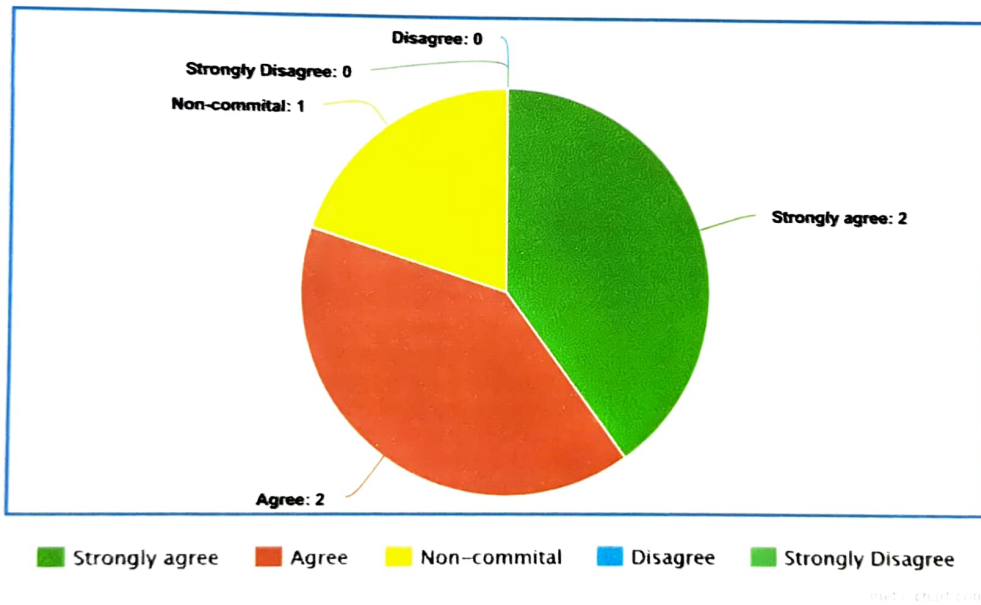
Do you think that the curriculum has made the employee conversant with the current trends in technology?
